FOR THE YEAR ENDED 31 MARCH 2019

The Trustees present their report and financial statements for the year ended 31 March 2019.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Trust's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016).

Objectives and activities

The Gwent Wildlife Trust ("GWT") Public Benefit Statement (as required by the Charity Commission) is enshrined in paragraph 3 of our Memorandum of Association.

1. For the benefit of the public, to advance, promote and further the conservation maintenance and protection of:
 - (i) terrestrial and marine habitats and their wildlife;
 - (ii) places of natural beauty;
 - (iii) places of zoological, botanical, geographical, archaeological or scientific interest;
 - (iv) features of landscape with geological, physiographical, or amenity value in particular, but not exclusively, in ways that further biological conservation.
2. To advance the education of the public in:
 - (i) the principles and practice of sustainable development;
 - (ii) the principles and practice of biodiversity conservation.
3. To promote research in all branches of nature study and to publish the useful results thereof.

GWT also delivers its public benefit through its membership of the Royal Society of Wildlife Trusts ("RSWT") and of Wildlife Trusts Wales ("WTW").

Summary of main activities of the charity in relation to its Goals

With regard to Goals 1 to 5. and 10., the main emphasis was conservation of terrestrial and freshwater habitats. Action for terrestrial and freshwater wildlife was achieved principally through nature reserve management, wider countryside conservation through the wider environment work, and through responses to the planning system.

With regard to Goals 6. to 9., the main emphasis was education with regard to biodiversity conservation, rather than a focus on sustainable development, although the latter does provide an important context for all GWT's work and is dealt with under Goal 12. GWT's Educational activities comprised work with schools, families and adults, through a combination of school visits (particularly to Magor Marsh, making use of the Derek Upton Centre), specific training events open to all, attendance and organisation of widely advertised public and community events. Such activities also take place through the Environmental Resource Centre ("ERC"), Ebbw Vale.

Regarding the remaining Goals, GWT has delivered its work through its Planning, Finance, Marketing and Membership Teams.

GWT's policy is to consult and discuss with employees, through unions, staff councils and at meetings, matters likely to affect employees' interests.

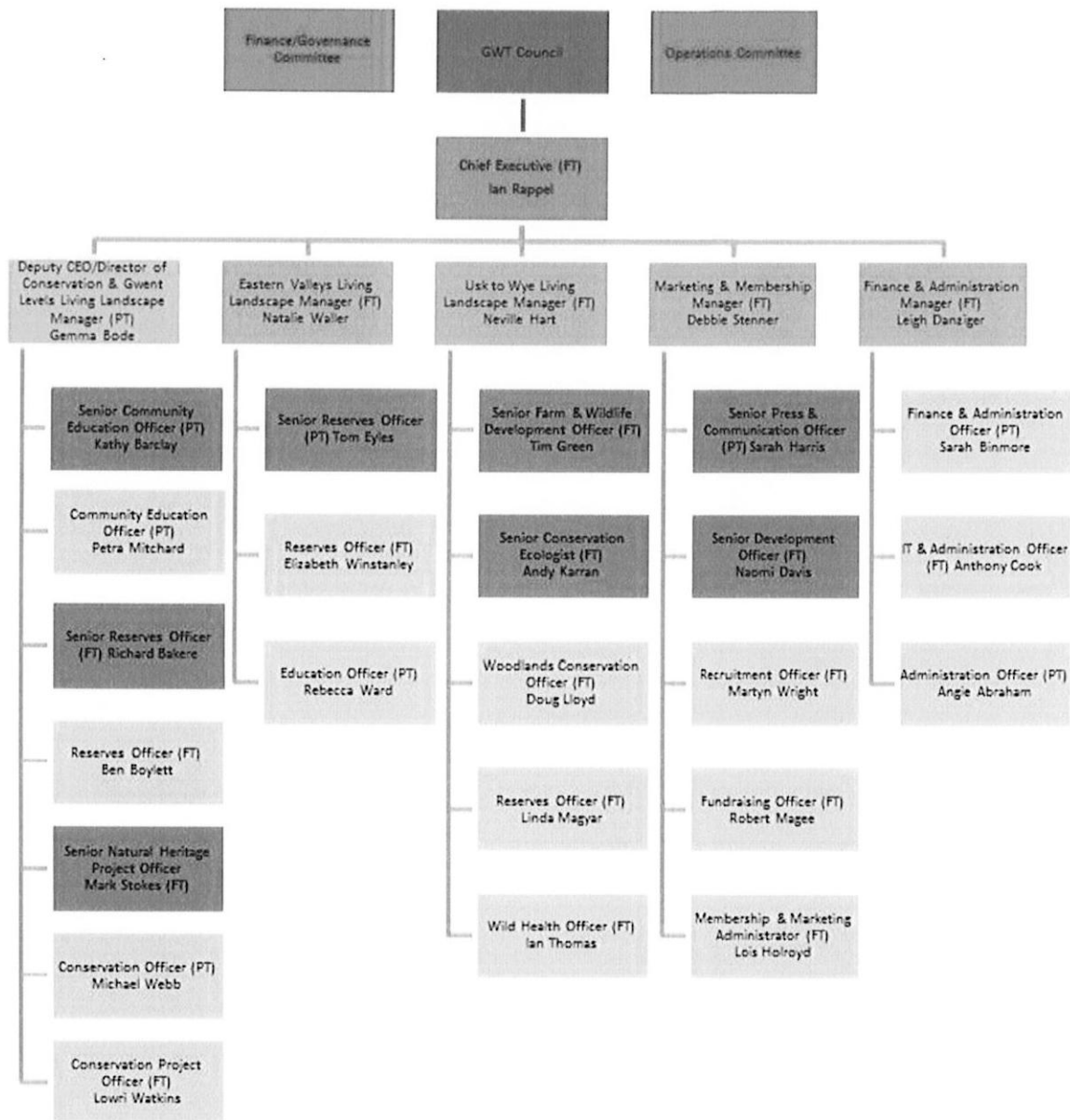
Information of matters of concern to employees is given through information bulletins and reports which seek to achieve a common awareness on part of all employees of the financial and economic factors affecting the trust's performance.

Achievements and performance

Investment performance achieved against investment objectives set

In the financial review section of this report there is a description of the investment policies and objectives established by the trustees and the extent to which social, environmental or ethical considerations are taken into account.

GWT's funds are held in two bank current accounts and four savings accounts (COIF higher-rate charity bank account, CAF/Shawbrook, Lloyds x2). Interest was received as expected from these sources.

Factors relevant to the achievement of the charity's objectives

No unusual factors that militated against the achievement of GWT's objectives were encountered during the year.

Summary of the main achievements of the charity during the year

All areas of GWT's work achieved satisfactory or good results during the year.

GWT ran its third full year of activities through its Living Landscapes structure between April 2018 and March 2019. The year was, again, one of high energy and notable success. These are some of the highlights for this year:

In the Gwent Levels Living Landscape Area:

The last year's activity across the Gwent Levels has continued at pace. The phenomenal volunteer support something in the order of 1000 days' reserve work, is really humbling. We're fortunate to have the additional input from Ben Boylett now as a Reserves Officer on the Levels, which has enabled this great volunteer resource to be even more effective. Just a few of the many highlights are the substantial new dipping platform at Magor Marsh. At Lower Minnetts the roadside hedge has been laid with great care by the Tuesday volunteers and is now a healthy living barrier, whilst at Great Traston Meadows some partnership working with NCC has enabled a number of new galvanised steel bridges to be built, assembled and lifted into place. A very healthy combination of volunteer activity, capital funding and contractor works. Species highlights include many daytime otter sightings at Magor Marsh and a welcome expansion in the breeding numbers of little egrets on the pond.

Our Education Centre at Magor Marsh continues to thrive, and during 2018 1000's of school children have learnt about the wonderful wildlife that can be found there, and lots of new visitors are still finding the reserve for the first time. We are getting lots more interest from wellbeing groups acknowledging the power of the natural world and using Magor Marsh to take time out with like-minded individuals.

Through our Lost Words Project we ensured every Primary School in Gwent received a copy of the wonderful Lost Words book and learning resource to accompany it. This was to inspire young learners and keep those wild words such as Ivy and Heron, now absent from the Junior Oxford Dictionary, alive in their vocabulary.

We continue to stand up for wildlife with our input into planning casework that affects wildlife. In 2018 we continued to input into our long term campaign against the M4 that would cut straight across the nationally important Gwent Levels with numerous guided visits for press and other interested parties. We also influenced solar farm and wind turbine applications on the Gwent Levels that affected ground nesting birds and the SSSI features of the area.

Our My Wild Newport Project has been focusing on working with Newport City Council and encouraging people to get to know their local green spaces and actively volunteer to help at them. This has generated great local enthusiasm for the local environment.

We also heard of 80 acres of land for sale east of Magor Marsh and began our fundraising Bridewell Appeal to help purchase the land as our newest nature reserve.

Our Heritage Lottery funded partnership Project the Living Levels Scheme continues to engage people with the value of the Gwent Levels. Over winter over 9km of field ditches were restored from dry double hedged ditches to watery boundaries full of nationally important wildlife re-colonising them. The learning element is making sure those teachers on the Gwent Levels know about its unique history and biodiversity and the team have produced the most wonderful learning resource for them to use www.livinglevels.org.uk

In the Usk to Wye Living Landscape area:

New Acquisitions: A 2-acre extension to Prisk Wood SSSI has enlarged the reserve and provided direct access onto Lone Lane to improve access and assist management. This land also supports some great habitat including impressive, veteran, small-leaved lime pollards. In addition, GWT has taken on a 10-year management agreement with the new owner of Piercefield Woods SSSI/SAC, a nationally important woodland supporting a range of inspiring woodland habitat, rocky gorge and riparian habitats, rare wildlife and important historic and archaeological features. GWT is working with the owner to manage the site to build greater opportunities for wildlife and better awareness and people engagement.

Woodlands: Winter management of our woodland nature reserves continued with just under 1 hectare of ride edges and woodland coups being coppiced by GWT staff, trainees and volunteers at Croes Robert SSSI, with the resulting timber being sold to a local wood fuel supplier and the remainder being converted into charcoal and sold to local markets. Viridor Credits, a community landfill fund provided funding to surface access tracks at Croes Robert SSSI, created and erected 2 interpretation panels for visitors and invested in woodland boundary fences. Funding from the Wye Valley AONB supported another winter, woodland traineeship who assisted in all aspects of GWT's woodland management whilst being trained in using chainsaws, ATV's, tractors and learning about sustainable woodland management for biodiversity.

GWT came runner up in the Wye Valley AONB Farming Awards in 2018 with the award for Outstanding Contribution in recognition of the restoration and management of GWT nature reserves across the AONB area, including the contribution made to conservation grazing and promotion of sustainable farming practices and meat production. The award was announced at the 2018 Monmouth Show.

Grasslands: Linda Magyar was appointed the U2W Grassland Reserves Officer to assist in the management of GWT grassland reserves, funded through the generous legacy left by Mrs Pat Gorvin, a county resident and long-time supporter and benefactor of GWT. Linda's employment provides greater resource to positively manage GWT nature reserves and has freed up time for other staff to focus on enhancing our conservation grazing efforts across the landscape. This remained a focus either through direct grazing of GWT's land holding, sales of organic, pasture-fed meat via the meat-box scheme or supporting other conservation grazing across the county.

Our involvement in land surrounding our HQ situated on the Dingestow Estate continued with the ongoing restoration of 120 acres of grassland, including registered, historic parkland habitat. Positive management to improve grassland diversity was implemented, alongside provision of rough grassland margins to boost small mammal populations that would confer benefits for resident kestrel and barn owls that breed on the estate. This was part funded by a donation from GWT's Usk Branch which also paid for management of an arable field for arable weeds and overwinter bird crops. Hedgelaying and new stock fencing was also completed via a Glastir small grant scheme.

In the Eastern Valleys Living Landscape area:

Natalie Waller joined GWT as the Landscape Manager in December 2018. The Eastern Valleys Team continues with their day-to-day work of managing our reserves, delivering school and community workshops, supporting sites in the wider landscape and working with partner organisations to inspire and influence local communities.

In terms of work on reserves, over 3km of replacement fencing at the top of Silent Valley has finally been completed this year. It has taken more than 50 days of staff time, supported by an estimated 100 days of volunteer time. This has made the site more secure from wandering sheep from the hillside above and so will improve regeneration of vegetation in some areas. The reserves staff continue to work alongside Ian, GWT's Wild Health Officer, hosting some of the groups which he works with, and they have contributed many volunteer hours in the Eastern Valleys which we are very grateful for.

The Team continues to deliver the Heritage Lottery Fund ("HLF") funded 'Where's Your Wildlife?' project focused on The British in north Torfaen, Central Valley and Silent Valley reserves (due to end Oct 2019). The project has delivered over 20 events for local schools and for the community, focussed on specific species which are found on the post-industrial habitats of the three sites. Some highlights have been working with the Colliery Spoil Biodiversity Initiative at The British and finding the nationally scarce *Andrena bucephala* (Big-headed Mining Bee), as well as working with a local poet in order to capture people's memories and experiences of the sites.

In the Eastern Valleys Living Landscape area: (continued):

A further highlight for our education work has been the continued relationship with Pen y Cwm Special School next door to the ERC, who regularly work with Becky in order to achieve their John Muir award. Additionally, 2019 was the most successful year so far for the Wildlife Wizards Quiz in Blaenau Gwent – 10 schools took part from BG, more than from any other authority!

In collaboration with Torfaen County Borough Council (“TCBC”) and the Friends of the British Group, GWT has been successful in its Enabling Natural Resources and Wellbeing (“ENRaW”) bid (a grant distributed by the Welsh Government) for the recruitment of a Community Warden for The British. This new post will sit within the Eastern Valleys Team for 1-year and it includes management costs to cover the Landscape Manager’s time.

The team continue to be a partner in the Resilient Uplands SMS project, delivered by TCBC, delivering training and habitat management advice as part of the project. They are also forging links with the Wildlife Trust of South and West Wales (“WTSWW”) with the long term aim of developing a landscape partnership project across the South Wales Valleys.

Closer to home, the ERC is now relatively flood-free during high rain fall, as Blaenau Gwent County Borough Council have carried out remedial works on the drainage channels and pipes on site, diverting excess water into the ponds. Additionally, the Council are currently being proactive in working out a lease agreement for the ERC site and Central Valley Reserve (the 3-year Management Agreement with the Council expired Feb 2019), and we are hopeful this will be resolved soon.

Elsewhere in Gwent:

Once again our Planning casework was dominated by the issue of the M4 “Black Route”. GWT continued its work with other concerned organisations, especially Campaign Against Levels Motorway (“CALM”), as well as producing a campaigning publicity video, securing a lot of local press and media publicity including television interviews filmed on Magor Marsh, and publicising and taking part in a demonstration outside the Welsh Senedd building in Cardiff Bay, along with other publicity measures. WTW has been involved in strong support for GWT all along. We are delighted at the recent announcement (June 2019) by the First Minister of Wales that he attached significant weight to the adverse effects which this project would have on the Gwent Levels and their wildlife, and that therefore he is not intending to expropriate the land that is subject to Compulsory Purchase Orders, nor will he make any further orders. We are delighted at this proof that this threat to the Gwent Levels has now been decidedly disposed of, and that our hard campaigning has paid off.

Support Team/Fundraising and Membership

GWT's income from memberships was £169,089 in 2018/19, and GWT welcomed 252 members. At the end of the financial year GWT had 3,373 memberships. GWT significantly grew the number of members recruited via their website, with 62 new members joining them online in the period, some as a result of membership promotions ran on social media.

GWT organised dozens of media tours of the Gwent Levels and Magor Marsh nature reserve to raise the profile of the area during the #SaveTheGwentLevels campaign against the new M4 motorway. As a result, GWT gained UK and national media coverage on: ITN News; the Guardian; the Observer; the Western Mail; Walesonline; BBC Wales Radio and TV; the Financial Times; Countryfile magazine; Countryfile Diaries; ITV Wales; and BBC Radio 2 and 4. 7,000+ people sent our #SaveTheGwentLevels campaign email, supported nationally by The Wildlife Trusts and across the movement, of objection to the First Minister. Triathlete Phil Tilley ran the inaugural Newport Marathon for GWT raising £717 and increased awareness of their campaign. More than 7,000 people watched and shared GWT's #SaveTheGwentLevels film, produced with pro bono support from professional filmmakers, showing footage of the wildlife on the Levels. The film illustrated the poem Leisure by WH Davies narrated by actor Aimee-Ffion Edwards. GWT gained celebrity support for their campaign from Stereophonics' Kelly Jones, former Sex Pistol John Lydon, and actors Aimee-Ffion Edwards and Hugh Bonneville.

GWT held their flagship Race for Wildlife 10k event in May, with over 200 runners participating. GWT also added the Silent Valley Challenge walk to their portfolio of fundraising events as well as investing in outdoor cinema equipment and holding 2 pilot events in Newport in the Summer.

GWT recruited 3 new business members, raising £7,000 from their engagement with regional businesses.

GWT held a busy programme of summer shows and events, including showcasing Gwent Wildlife at the Hay Festival in Wales, and the agricultural shows in Monmouth, Usk and Chepstow having invested in an exhibition trailer to facilitate this.

GWT's holiday cottage at Pentwyn Farm Nature Reserve had another successful year, with a 75% occupancy rate over the period.

Pat Gorvin Legacy

During the previous year GWT received a significant proportion of the Pat Gorvin Legacy (£2,610,000). Mrs Pat Gorvin was a member of GWT from the mid-1960s. Pat and her husband supported GWT through thick and thin until their old age. Pat survived her husband and continued to help GWT – donating £50k in the year of GWT's 50th Anniversary. Sadly, Pat passed away in 2016 but left 60% of her estate to GWT in her will. That generous action has bolstered GWT's work through an injection of over £2 million. Such substantial gifts are uncommon and will help GWT deliver better outcomes for wildlife and people's enjoyment of biodiversity in Gwent. Funds have been Designated to bolster conservation efforts, and to invest in the long-term sustainability of GWT. The Designations, estimated to last 5 years from receipt of Legacy Funds, are as follows:

A steering group, comprised of Trustees and Senior Staff, ensures that funds are applied in ways consistent with GWT's Charitable Objectives and its Strategic Plan. The Income Generation Designation is particularly significant since this is where GWT's Legacy funds are applied to enable continued charitable function after the five years duration of the Gorvin Legacy fund. The Revenue Protection Designation ensures that GWT retains its effectiveness and capacity during the period of the Gorvin Legacy Fund.

Gwent Ecology Limited

Gwent Ecology exists to fulfil a number of purposes. Principally, it generates unrestricted funding for GWT. Professional consultancy work, from bat surveys to large-scale landscape design, is fulfilled using a mixture of GWT staff and external sub-contractors. In addition to generating profit, Gwent Ecology makes a direct contribution to cover staff-time, training and other overheads for those GWT who work on projects. It also provides a vehicle to enable staff to grow their own professional skills and abilities in a commercial setting and, potentially a future career opportunity for staff as the business develops.

Perhaps most important of all, it enables GWT to directly influence from within developers, private, corporate and governmental, ensuring the projects that GWT assist with are delivered with biodiversity issues properly considered and addressed.

Gwent Ecology delivery: Andy Karran was seconded to deliver work for Gwent Ecology, who were contracted by TCBC to undertake surveys to assess 49 potential strategic development proposals within their Local Development Plan, impacting 56 Sites of Nature Conservation (SINCs) of which 25 were surveyed in detail. The report will assist TCBC ecologists and planners to assess the impacts of development proposals and help make appropriate strategic decisions across the local authority boundaries.

Financial review

The Statement of Financial Activities show incoming resources for the year of a revenue nature of £763,729 (2018: £3,333,024).

The total reserves at the year-end stand at £3,543,337 (2018: 3,900,939).

Brief details on the scope of funds relating to:

Eastern Valleys Living Landscape: Royal Society for the Protection of Birds ("RSPB") (Heads of the Valleys Lapwing Project); Heritage Lottery Fund ("HLF") ("Where's Your Wildlife?"); Leonard Cheshire; (Better Woodlands for Wales); Wales Council for Voluntary Action ("WCVA") (Silent Valley Woodland); Forgotten Corner Appeal.

Reserves policy

GWT aims to hold an unrestricted financial reserve equal to a minimum of 3 months operating costs at £200,000. This was achieved during the year, and the year closed with an unrestricted reserve of £2,157,371 of which £2,001,818 is designated.

At the year-end, there was a deficit in Springdale Glastir Advanced of £52 to be repaid by December 2019, in Glastir Advance of £6,440 to be repaid by December 2019, in Living Levels Natural Heritage Restoration of £7,069 to be repaid by July 2021, in Living Levels Education & Local Wildlife Sites of £3,565 to be repaid by July 2021, and in Bridewell of £54,817 to be repaid by July 2019. There was also a deficit in ABP Gwent Levels of £757, in Wildlife Wizards of £285, in the Dingestow Old Court of £1,857, and in Wild Health Project of £6,382; all to be repaid during 2019/20.

During the year, Gwent Ecology Limited elected to gift £11,603 (2018: £10,984), being its profits for the year ended 31 March 2019, to Gwent Wildlife Trust Limited.

The company is limited by guarantee and therefore has no share capital.

GWT is guided by its Development Plan and is producing a 5 year Strategic Plan.

Ian Rappel Chief Executive

The Trust is governed by its Memorandum and Articles of Association, which were revised at the Trust's 2005 AGM. They were further amended at the 2010 AGM to give the trustees discretion to appoint a patron of the charity. At the 2012 AGM, a resolution was agreed to increase the maximum number of trustees from 12 to 15 and to allow trustees to serve for two consecutive terms of five years. Further information and guidance on the running of the Trust is provided by the Trust's handbook, which is revised regularly.

Trustees are elected by the membership at the Annual General Meeting. A new appointment process has been set up in the course of the year 2018/2019, whereby all would-be trustees complete application forms; suitable candidates are then shortlisted for interview by a panel of trustees and a staff member; and recommendations for co-option are then made at the following meeting of Council. Co-opted trustees will then be recommended to the membership for election at the following AGM. Potential trustees can contact GWT direct for a form; but in order to increase the trustee diversity, advertisements are now being placed when there are vacancies on Council and this has resulted in an increase in younger trustees and in a greater percentage of female members.

None of the Trustees have any beneficial interest in the company. All of the Trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

GWT is guided by its Strategic Plan which was adopted in 2012. A new Plan is currently being drawn up and will be available for view at the AGM in September 2019. GWT's council meets six times a year to make decisions on policy and strategy. A work plan and budget for the year is set at the March Council meeting. An Annual Report and Accounts is presented to the May meeting of council and thereafter to the Annual General Meeting in September.

Day to day management of the Trust is delegated by the Trustees to the Chief Executive. Members of staff undertake work in line with the organisation's strategy, policies, work plan and budget. Staff, trustees and other appropriate individuals meet regularly in advisory working groups.

Following election of co-option of a Trustee, the Chair will introduce the new Trustee at the first meeting of Council attended. New induction processes and procedures are currently being put in place.

Membership of a wider network

GWT is part of the Wildlife Trusts partnership, which encompasses 46 Wildlife Trusts covering all of the UK, plus the Isle of Man and Alderney. Within this wider network, GWT works particularly closely with the other four Welsh Wildlife Trusts (Brecknockshire Wildlife Trust has merged with Wildlife Trust of South and West Wales).

Relationships between the charity and related parties, including subsidiaries

GWT is a corporate member of, and pays contributions to, the RSWT and WTW, both of which are registered charities. GWT provides a trustee to WTW, and WTW provides a Trustee to RSWT.

GWT is divided into the following departments: Finance & Administration, Marketing & Membership, Eastern Valleys Living Landscape Area, Gwent Levels Living Landscape Area, and Usk to Wye Living Landscape Area. During the financial year being reported upon, Gwent Ecology Limited provided a range of ecological services to local organisations.



1 Accounting policies

Charity information

Gwent Wildlife Trust Ltd is a private company limited by guarantee incorporated in England and Wales. The registered office is Seddon House, Dingestow, Monmouth, Monmouthshire, NP25 4DY, United Kingdom.

1.1 Accounting convention

The accounts have been prepared in accordance with the Charity's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The Charity is a Public Benefit Entity as defined by FRS 102.

The financial statements are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Thus the Trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Designated funds comprise funds which have been set aside at the discretion of the Trustees for specific purposes. The purposes and uses of the designated funds are set out in the notes to the financial statements.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

1.4 Incoming resources

Income is recognised when the Charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the Charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

Turnover is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods and services provided in the normal course of business, net of discounts, VAT and other sales related taxes.

1.5 Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

1 Accounting policies

1.6 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following bases:

Plant and equipment	25% on cost

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognised in net income/(expenditure) for the year.

1.7 Heritage assets

Heritage assets relate to the charity's nature reserves which are recorded at cost.

The heritage assets have been reviewed at the reporting date with no impairment noted.

1.8 Impairment of fixed assets

At each reporting end date, the Charity reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

1.9 Financial instruments

The Charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the Charity's balance sheet when the Charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method.

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

1 Accounting policies

Derecognition of financial liabilities

Financial liabilities are derecognised when the Charity's contractual obligations expire or are discharged or cancelled.

1.10 Employee benefits

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the Charity is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

2 Critical accounting estimates and judgements

In the application of the Charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
