A Thurrock Watchman intercessors prayer group which is headed up by one of the trustees and has met three times this year. Also support for the women's world day of prayer, the week of Christian unity and the Thy Kingdom Come week.

The First Refresh event the feedback was for more information on strategic information so the first quarterly event in 2020 will have the CEO of Thurrock Council speaking about community involvement and an overview of countywide networks. In addition, there was a request for awareness on the use of social media and training was offered throughout the year.

Transformation Thurrock organized and promoted the General Election Husting for the two constituencies, working with churches and the press.


