**Trustees' Annual Report**

**For the period from 11 May 2018 to 31 March 2019**

South West Support and Awareness Group (Charity No.1178353) is a Charitable Incorporated Organisation (CIO) and was established on the 11 May 2018 with the Charity Commission for England and Wales. The principle address is 19 Windermere Crescent, Derriford, Plymouth, Devon PL6 5HX. The charity operates under the name of SWASAG.

**Objects of the charity**

The objects of the charity are:-

- (a) to preserve and protect the physical and mental health of sufferers of asbestos related illnesses within the geographic area of the South West of England, through the provision of financial assistance, support, education and practical advice, in particular but not exclusively to:
  - (i) help improve the living conditions and quality of life of sufferers;
  - (ii) develop local support groups; and
  - (iii) bring together in conference and work in liaison with representatives of voluntary organisations, government departments, local and other statutory authorities and individuals.
- (b) to advance the education of the general public, within the geographic area of the South West of England, in all areas relating to asbestos related illnesses including but not exclusively by providing information about the hazards of asbestos in the environment, and how to obtain reparations and other funds.

**Public Benefit**

The trustees have had regard to the guidance issued by the Charity Commission on public benefit and believe the main activities undertaken to further the charity's purposes for the public benefit.

**Structure, governance and management**

The charity's governing document is the CIO foundation model agreed by the applicants on 1 May 2018 and registered with the Charity Commission for England and Wales on 11 May 2018.

The trustees are selected on the basis of their skills, knowledge and experience needed for the effective running of the charity.

Trustees are appointed for a period of three years except in the first year where it can be for less. There must be at least three trustees.

## **Trustees' Annual Report continued**

### **Main activities in the period**

The charity officially launched in November 2018 and since inception the focus has been on improving the quality of life for those diagnosed with asbestos related illness throughout Devon and Cornwall. This has been achieved, in part, by the establishment of monthly support/coffee mornings in Plymouth and Truro and latterly in Barnstaple. The content of the meetings are very much peer led and we respond to any requests for professional speakers.

The charity has also sought and achieved, full membership of the National asbestos forum thus ensuring an element of governance with respect of the development of the solicitor panel, and all the solicitors on the panel list have been very supportive of all the activities the group organises.

In January 2019 a large memorial fundraiser was organised in Lanivet, Cornwall, which proved to be a huge success and which will become an annual event.

In June 2019 the charity was involved with Armed Forces Day on Plymouth Hoe, celebrating the armed forces but also highlighting the work of the charity whilst raising awareness of asbestos related illness in service. It was a very successful day, and again one we hope to attend annually.

July 2019 brings another annual event, namely Action Mesothelioma Day and SWASAG chose to mark the day with a 3 course meal in St Elizabeth's House, followed by a small service of remembrance and a butterfly release. The event was attended by our current patients, and our bereaved relatives, with an update on where we are with diagnostics and treatment given by medical staff from Derriford. It was a very well received day, and again, encouraged by our members, will become an annual event in St Elizabeth's.

October 2019 brings Mesothelioma UK's annual patient and carer day, at which patients, carers and professionals are updated with all the current best practice in asbestos related illness. The night before is marked with a social event and this year's event was held in Blackpool with the theme of Strictly Comes Dancing. The idea of offering to fund members on the trip was floated early in the year, and by the time the day arrived, we found we were taking 50+ of our members on the 2 night extravaganza. SWASAG fully funded the event and it was massively appreciated by all, so much so that we are in the planning stages for Southampton 2020.

Late November 2019 will herald the annual Christmas Dinner in the Carlton Bay Golf Course in St Austell. At the time of writing there are 52 attendees, with transport arranged for those who require it.

The trustees have also attended fundraising events organised by the local community, the largest being held in Cornwall by a group of young men who offered to fundraise by participating in the Banger Rally, driving a car from Lands End to Pompeii. It was a magnificent effort and we are very grateful. We are currently considering further fundraising events that both the trustees and the group members can be involved with.

In addition to the patient focussed events, the trustees have also welcomed requests for financial support from healthcare professionals who wish to attend relevant educational events. In January 2019, the pleural fellow from Derriford was funded to attend the British Thoracic Oncology Conference in Dublin. In 2020 the Lung Cancer Nurse from Truro will be funded to attend the same conference. The Mesothelioma Nurse Specialist from Derriford will be funded to attend the bi annual international Mesothelioma conference in Brisbane Australia. The trustees also funded the recent Multi-Disciplinary Team Business Meeting for the Derriford Lung Cancer Team allowing the attendance of every relevant consultant.

The trustees have also, recently, approved the release of funds to purchase a significant number of thermometers for those patients on low income who would struggle otherwise to receive chemotherapy safely.

In the coming 12 months we intend to continue with those events that are beneficial to our members and to build on the success of the last 12 months.

**Financial Review**

The trustees are pleased with the level of donations in this starting period of the charity which total £26,995 which are all unrestricted. Expenditure was £7,187 and therefore at the end of the financial year there was £19,808 in the charity bank account which represents unrestricted funds. During the period we purchased a laptop and collection cans.

As we are a newly formed charity the trustees will hold sufficient cash reserves to meet future plans and to protect against unforeseen future expenditure.
