OBJECTIVES

- (1) To advance the education of pupils in the school in particular;
- (2) Developing effective relationships between the staff, parents and others associated with the school;
- (3) Engaging in activities or providing facilities or equipment which support the school and advance the education of the pupils.

REVIEW OF THE YEAR

Over the past Year the Friends of Collett have successfully fundraised for a new sensory room, IT equipment and an innovative mobile café project which won a Community Grant Award.

The Friends of Collett organised several events during the year including a Charity dinner and auction, and a Race night. The charity wishes to thank all those who have so generously supported its work whether by gift of their time, talents, products, volunteering or financial donations. In particular the Trustees would like to thank Warner Bros, The Lords Taverners and HCF for their continued support.

The Friends of Collett were grateful for one-off grants that were received during the year from organisations and patrons such as Experia and The Lords Taverners.

PLANS FOR THE FUTURE

During the coming year The Friends of Collett School plan to raise funds to enable the school to meet the **toilet facilities** safeguarding, health and wellbeing requirements of our pupils.

The current building was built in the 1960s for able-bodied mainstream children and was changed to a Special Educational Needs School some 20 years ago. The current toilet facilities are inadequate, not fit for purpose and repellent to the Special Educational Needs children now occupying the school.

Teaching a child with Autism, or many other Special Educational Needs, to use the toilet can take longer and be more complex than for other children, and it can be highly stressful and challenging.

Children with Autism can struggle to understand social interaction and unwritten rules of behaviour, which inhibits their ability to interpret what is expected of them and to know how to behave around others. In the context of toilet training, this can mean they do not have the usual social motivation to be like their peers. This makes it harder for children to move from nappies to underwear or a potty to a toilet.

Sensory differences

The sensory differences of children with Autism can make it hard for them to recognise when their bladder or bowel is full, or they may find it difficult to balance on the toilet itself.

The bathroom itself can be overwhelming for some children, whilst being full of fantastic sensory input for others.

For instance, some may feel a splash of water or sound of the flush too intensely and experience sensory overload, while others may enjoy all of the sensory distractions in the bathroom and forget about the toilet. Sensory sensitivities can be hard to address, but *understanding the child's sensory needs and adapting the toilet environment can make all the difference.*

Schools and toileting

Learning to use the toilet is an important part of growing up. Achieving continence can help boost a child's self-esteem, give them and their families' access to a wider range of activities, and help reduce stress and anxiety for them and all involved in supporting them. Avoiding placing the child at a substantial disadvantage relative to others.

A child may consciously or unconsciously ration their fluid intake, or avoid drinking altogether, if they fear not being able to go to the toilet when they need to. Pupils may also avoid emptying their bowels at school. This can be due to a lack of privacy and poor toilet conditions. Holding on can lead to constipation, which in turn can result in soiling. Having toilets that the pupils refuse or cannot use can have both physiological and psychological consequences for the children. A significant proportion of childhood urinary and bowel problems are caused by unhealthy toileting patterns.

Conditions which can impact on bowel or bladder control include Crohn's Disease, Hirschprung's Disease, Vater Syndrome, Spina Bifida, Cloacal Exstrophy, Ectopic Bladder, Eagle-Barrett Syndrome, Ulcerative Colitis etc

Pupil "Voice"

We always take into consideration the views of the child / young person. It is important for the pupil to feel they are in control of their personal care and it is not something that is 'done to' them. To support this, young people have been actively involved in the decision making. Many of our children have demonstrated a reluctance to go to the toilet, a sudden increase in the number of accidents or stopping eating and drinking to prevent needing the toilet. So the School Council produced a questionnaire, the results of which showed half of girls and two thirds of boys avoid using school toilets due to unhygienic conditions and fear of the facilities.

OUTCOMES

- Increased independence
- Better physical health

We plan to fundraise for **IT** as all our computers are those discarded by local Primary schools who have updated.

The Friends of Collett also hope to fundraise to provide the correct **lighting** for our pupils needs. Removing the current fluorescent lighting in school and replace it with soft LED lighting which for most of our children appears as a requirement in their Education Health and Care Plan (EHCP) to support the sensory and learning needs of our children with Special Educational Needs. Many people have seen special needs children having tantrums, screaming, kicking out. Nearly all of our parents can tell you how their child have been labelled as naughty. But what is really going on here? Often what we are seeing is sensory overload. Imagine not being able to take in the environment around you. There is white noise filling your head. Lights shine harshly on your eyes, in some cases actually triggering feelings of nausea, headaches, confusing the brain. Strobe lighting has been linked with epileptic fits for many years (which several of our children also suffer with, but now it has been shown that in fact fluorescent lighting has the same effect. There is a sub-visible flicker given out from fluorescent lighting that causes an increase in repetitive behaviours, headaches, mood changes and concentration problems in special needs children. But think, which of us hasn't had headaches from sitting in bright fluorescent lit rooms? Think then of children so susceptible to sensory overload spending every day in these environments. The worst thing is that the children are unaware of the cause of their stress. But the results from their sensory distress is overwhelming.

The fluorescent lights have been scientifically proven to cause behavioural issues in children with special needs due to the sub visible flicker. It can also cause concentration difficulties and malaise. The objective of our project is to help relieve the sensory difficulties lighting within school is placing on our children. Replacing fluorescent lighting with LED lighting is shown to increase concentration and focus attention, improve alertness and mobilisation, as well as a reduction in impulsive and repetitive behaviours. This will allow our children to have an optimal learning zone, supporting the efforts of teaching and professional staff and increasing the development of the children.

RISK POLICY

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

PUBLIC BENEFIT

In setting our programme each year we have regard to both the Charity Commission's general guidance on public benefit and prevention and relief of poverty for the public benefit. The trustees always ensure that the programmes we undertake are in line with our charitable objects and aims.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The Constitution requires the trustees to prepare accounts statements for each financial year that give a true and fair view state of affairs of the organisation and of the income and expenditure of the organisation for that year. In preparing these financial statements, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Make judgements and estimates that are reasonable and prudent;
- Followed applicable accounting standards and statements of recommended practice without any material departures;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in business.
