#### Report on Trust Activities during the Year 2018/19

#### General

#### Administration

- The annual accounts for 2017/18 were successfully audited.
- Job description for a Grounds Manager to be put together and advertised.

#### Halls/Pavilion

- Fire and H&S risk assessments minimal works still to do.
- Asbestos and legionella assessments were carried out and appropriate measures put in place.

#### Recreation Grounds

- A single red oak has been planted on each recreation ground to commemorate the ending of WW1.
- The annual play inspection has only low risk items which will need to be assessed and costed.
- New woodchip has been added to all three play areas although in the recent annual inspections this may have to be looked at further.
- Annual inspections received, low risk items only flagged up for attention.

## FRAMFIELD MEMORIAL HALL AND, RECREATION GROUND TRUST. Charity Registration No. 305228

#### Memorial Hall

- Repairs to the retaining walls, steps and rear paths behind the Hall have been done. A quote has been sourced to re-tarmac the area to the rear and sides of the Hall.
- The Hall floor was deep cleaned and sealed.
- Memorial plaques to be placed in a cabinet and positioned in the Hall.
- A model of the Parish is to be mounted and placed in the Hall.
- A new ten-year hire agreement has been agreed with ESCC for the use of the Hall by the School.
- The Stagers were given a reduced price for the use of the Hall for their 2019 production. A meeting is to be held prior to the 2020 pantomime.

#### Recreation Ground

- Basketball grant (Tescos). The area is completed with a quote for the painting of the MUGA to be sourced.
- A grant was successfully achieved (£7k) to enable new fencing to be installed around the play area.
- Storage container anti-climb paint is to be put round the container in a further attempt to stop children climbing on the top.
