Structure, Governance and Management

Governing Document

Barnstaple Musical Comedy & Dramatic Society (BMCDS) is a not-for-profit company limited by guarantee and is also a registered charity. It is controlled by its governing document, a deed of trust.

Appointment of Board Members

As set out in the governing document, the Directors are appointed by the members at the Annual General Meeting.

Where casual vacancies arise, the Directors may appoint a Director to serve as a Board Member until the next Annual General Meeting, at which point they are required to retire but will be eligible for re-election.

Organisation

The Board of Directors meet monthly and are responsible for administering the company, having regard to advice from the development executive and other advisors.

Risk Management

The Directors have a duty to identify and review the risks to which the company is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error. The Directors have examined the major risks that BMCDS faces and this has resulted in additional efforts to increase its donor base.

Objectives and Activities

The objectives of BMCDS are to educate the public in the dramatic and musical arts and to further the development of public appreciation and taste in the said arts by the promotion and public performance of plays, drama, comedy and other dramatic and musical work. When carrying out the activities of the charity the directors have had regard to the guidance issued by the Charity Commission on public benefit

Achievements and performance (Chairman's Report)

I would like to start my report with a big Thank You. Thank You to everyone who has played a part in our society over the past year and beyond. Whether you have been on or off the stage, whatever part you have played, Thank you.

BMCDS continues to push the boundaries of amateur theatre and continues to produce some of the best Musicals and Plays and continues to perform at the top of its game. I haven't been on the production team of any of the shows over the past 12 months which has afforded me the very privileged position of being able to sit in the audience and watch our amazing shows. I have to say that I think we have smashed the ball out of the park on every single show we have produced. That's all down to the huge amount of work that goes in all year round by too many people to mention individually so again, Thank You. I hope you've enjoyed the journey and I hope you will continue to help and support us in the years to come.

The Wizard of Oz

We started our year with BYG's production of The Wizard of Oz. This was a wonderfully colourful show with a brilliant performance from such a young and talented cast. I know there is a saying that you should never work with Children and Animals, the children were great but trying to get a license for a performing Dog proved a little tricky. Particular thanks go to Julie our Producer, Dom our Musical Director, Lauren our Choreographer and Jordan our Director for putting together such a great show. We have had some questions recently about there not being a BYG show this year, so I will explain our plans a little later.

Private Peaceful

In the summer we moved on to Private Peaceful, a very sensitive, thought-provoking and moving play directed by Jordan assisted by a team of people behind the scenes. It was a wonderful opportunity to portray a key part of our history. With a simple yet effective set enhanced by some beautiful period costumes, it encouraged the audience to picture for themselves life during a very different time in our country's history. Huge thanks go to everyone involved with this very special piece of drama.

Sunset Boulevard

We now move on to Sunset Boulevard. Our usual November slot had originally been allocated for Chitty Chitty Bang Bang but due to a number of issues we had to move it. To ensure we didn't cancel our weeks booking it was suggested that we could produce something that would again push us out of our comfort zone a little, so we agreed on Sunset Boulevard. In the previous weeks before the show I had taken part in both Barnstaple and South Molton Carnivals and we had the Sunset music playing as we handed out cards. I have to admit it took a little while for the music to grow on me. However, during show week, I sat in the audience on the Dress Rehearsal and I was amazed. The show was totally brilliant. The music was haunting, and the parts were played beautifully. From then on I watched every performance and loved every minute. Special mention must go to lan for stepping in to take on the role of Joe. Thanks to Julie for producing, Gillian and Paul for musically directing, to Lauren for choreographing and to Jake whose direction brought the whole story to life.

Chitty Chitty Bang Bang

So now on to Chitty Chitty Bang Bang. Well where do I start? When we were offered the licence 12 months before it went on general release, we all agreed that if we were going to do it we would need to do it properly. So, we started to look for a set, costumes and most importantly, a Car that could Fly! As I've already mentioned we were offered the license 12 months before the show went on general release, which is a huge compliment, unfortunately on this occasion it caused big issues as no one actually had a set or costumes and certainly no flying cars. After a huge amount of searching we came to an agreement with a company on the Isle of Man who were offering to build everything and transport it to us. They were also producing the show themselves so everything would be ready in time for our November slot. As I'm sure you can guess things didn't turn out as planned, the company who were supplying everything to us had booked another society for the same dates as us and because they were booked for 10 performances and we were only 6 they cancelled our booking. This caused us to have a complete re-think on our dates. Fast forward a few months and we were heading towards Christmas with the show to be performed at the end of January. Again, the same company first cancelled the costume hire and after a bit of detective work from our end we found that the flying car had again been double booked to a company in Ireland. With this we cancelled everything and managed to source the set & costumes from other suppliers. Just before Christmas with just over a month to go we managed to speak to a company who had just bought a Chitty car for their own show this August 2020, however they were in Norfolk and the car wasn't really useable. The car needed a lot of work, but they very kindly agreed to work throughout the Christmas period and beyond to try their best to get the car Show Ready for the end of January. We continued to keep in regular contact and with just a couple of weeks to go before 'get in' The Sound Ideas Theatre Company' said that they were certain that the car would be ready for us. We arranged everything with the Queen's Theatre to get her delivered on the Friday evening before our show. Unfortunately, the problems didn't finish there, but you don't need to hear all about that. Come opening night we were as ready as we could have been. The whole show was amazing, but I have to say that Chitty stole the show when she took off over the Orchestra Pit. We had some amazing reviews and comments and even with all the increased costs that come with putting on a show like Chitty, we still made a little bit of money. Huge thanks and congratulations go to everyone who took part in making this extravaganza possible. Thank you to Julie our Producer, Paul our Musical Director, Lauren our Choreographer and Jake our Director, for producing a wonderful show. There are always ups and downs with every show but I think Chitty Chitty Bang Bang will go down in history.

42nd Street

Although 42nd Street falls into our 2019/2020 year, it would be wrong of me not just to mention it. The performance of everyone involved in the show both on and off stage was just breath-taking. The show was perfectly rehearsed and was received so well by extremely happy audiences every night. I will of course go into more detail next year but a huge thank you again to everyone, it is another BMCDS show that will keep people talking for a very long time.

Special thanks to Helen and the rest of the teaching team who continue to pass on their knowledge and encourage our students to grow as individuals. Centre Stage itself is a great venue and something we are always extremely proud of. Again, this was just a nice idea to start with and now I can't imagine BMCDS without this amazing home. Thanks to Miles and everyone else who work to keep this place in great condition and here's to another successful year, thank you.

Finance

As you can see from our accounts we continue to keep a constant grip on our financial position. It is always the case, but this year I would like to say a particular special thank you to Julie for everything she has done to keep things in check. We have had a very unsettled time recently particularly with the transfer between Parkwood Theatres and Selladoor Venues. Julie has worked tirelessly to ensure we are in a good shape. So Thank you.

pattern we are currently working with. Back in North Devon Theatres days we always had the usual

May BYG slot and November BMCDS slot. For years we carried on the same way and it worked well. When NDT went into administration everything went out the window. Unsurprisingly prices went up and we had to be much more flexible with our dates. Add to this the fact that the theatre is now offering a wider range and are including more professional touring musicals, we need to make sure that whatever we produce can compete in that market place. When we look at ticket sales, it is all very well having the kind support of the cast's family and friends but even if every cast member managed to encourage 10 people each to come that would still only give us about a 5th of what we need to cover the cost of putting on a show. As you can see from our accounts, we are in the very fortunate position of being able to indulge ourselves once in a while by putting on something that might not be commercially attractive but is something that we would really like to do. We aren't in that position just by chance, we are there because of the huge amount of work that goes on throughout the year by so many people. So again, thank you to everyone for helping us do what we do.

So now we look to the future. Just to reiterate my comments earlier with Selladoor Worldwide bringing both Fame and Madagascar to the Queen's Theatre this Autumn we decided that we wouldn't produce another musical this year. So we have Allo Allo coming to Centre Stage in August and the Haunting of Hill House also here in October. Both of these are very different but promise to be excellent entertainment. In 2020 BYG are back in the Queen's Theatre with Little Shop of Horrors. Look out for Audition dates and more details on our Facebook pages.

I'm going to finish my report for the year as I started it. Thank you to everyone involved with our great society, Thank you for everything you do, Thank you for being part of (in my opinion) the best Amateur Society in the South West. Here's to a great year. Thank you.

Financial Review

Investment Powers and Policy

Under its governing document, the company has the power to invest in any way the Directors see fit and having regard to the liquidity requirements of operating the company.

Reserves policy

The directors aim to maintain sufficient money in the bank to be in a position to meet any unexpected expenditure. At the year end Cash at bank and in hand came to £43,749 (2018 £60,906), a figure considered more than adequate.

Dissolution

Every member of the company undertakes to contribute amountws (but not exceeding £1) towards the settlement of the company's debts and liabilities if it is wound up. If, a fter settlement of all debts, there are funds remaining, these will be transferred to another charitable organisation with the same or similar objectives to BMCDS.

Directors' Responsibilities for the Financial Statements

The Directors are responsible for preparing the Annual Report and the Financial Statements in accordance with applicable law and regulations.

Company Law requires the Directors to prepare Financial Statements for each financial year. Under that law the Directors have elected to prepare the Financial Statements in accordance with United Kingdom Generally Accepted Accounting practice (United Kingdom Accounting Standards and applicable law). Under company law the Directors must not approve the Financial Statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the net incoming or outgoing resources of the company for that period. In preparing these Financial Statements, the directors are required to:

- Select suitable accounting policies and then apply them consistently;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the Financial Statements;
- Observe the methods and principles in the charity SORP; and
- Prepare the Financial Statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The Directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the accounts comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Disclosure of Information to the Independent Examiner

Each person who was a Director at the time of this report was approved confirms that:

1 Accounting Policies

Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Statement of Recommended Practice: Accounting and Reporting by Charities (FRS 102) issued on 16 July 2014 and with the Charities Act 2011.

Incoming Resources

The income shown in the Statement of Financial Activities represents:

- Income from donations and grants recognised where there is an entitlement, certainty of the receipt and the amount can be measured with sufficient reliability;
- Income from charitable activities on an accrual basis; and
- Income from investments on a received basis.

When donors specify that funds given to the charity are for use in future accounting periods, such income is deferred until those periods.

Resources Expended

Resources expended are accounted for in the Statement of Financial Activities on an accrual basis.

Restricted funds

Restricted funds are funds given for a specific purpose.
