To promote social inclusion for the public benefit amongst women asylum seekers and refugees in Wales by preventing them from becoming socially excluded, relieving their needs and assisting them to integrate into society.

For the purpose of this clause 'socially excluded' means being excluded from society, or part of society, as a result of being a member of a socially and economically deprived community

To advance the education of the public in general about the issues that relate to refugees and those seeking asylum.

WSSAG has attended a number of networking events and meetings to raise awareness of our organisation and the work we do. This networking is very important to the work and services we provide as we have been able to identify key partners working in the area of campaign and support for women's issues.

WSSAG has built strong partnerships with various organisations that will help with signposting refugee and sanctuary seeking women to our organisation among which Welsh Refugee Council, Trinity Centre, Lynx House, Community for Work, local faith groups, Ethnic Minorities and Youth Support Team Wales (EYST) Birth Partner Project, British Red Cross, Displaced People in Action, Migrant Help, Women Equality Network, Cardiff University (Live Local, Learn Local) and Virgo Law Consultancy.

WSSAG worked with Cardiff University in delivering to our members various courses. A representative from Cardiff University Live local, Learn Local attends our office and our members and other women in the community have been able to undertake courses. The University was also able to promote opportunities and availability of courses and support.

One of our aims is to empower women seeking sanctuary to become more independent and this we feel is achieved in many different ways. WSSAG hosted monthly Coffee Mornings for members and the public as a whole to drop in and meet others, who share similar experiences, receive peer support and breakdown isolation by encouraging socialisation.

FareShare and WSSAG have started working together to provide fresh fruits and vegetables and bakery to vulnerable families.

To summarise, while some activities were educational, lots of activities organised were to educate and promote the social inclusion of women seeking sanctuary and also to educate the public about our service users group.

Summary of the main achievements of the charity during the year

The organisation has strengthened its links with The Church In Wales all over Wales through the provision of donations of clothes and toiletries to support vulnerable women and children.

New partnership was established with the Communities for Work to support the women with job search skills, CV writing and interview preparation to enable them to be well equipped when facing job search.

FareShare and WSSAG have started working together to provide fresh fruits and vegetables and bakery to our members.

WSSAG organised an International Women's Day event in March in which 50 families attended and we were privileged to have 3 influential speakers (a Solicitor, a coach and a survivor of domestic abuse) who spoke and shared their experiences on resilience and overcoming challenges.

A major achievement this year was to be selected among some women's organisations to be part of the Women's Equality Network – ROSA partnership mentoring programme.

Monthly coffee mornings for women seeking sanctuary, with guest speakers from different organisations including C3SC, BME Skills Project, Communities for Work, British Red Cross, Wales Ambulance Service, Migrant Help, Sherman Theatre 5 were organised throughout the year.

We have engaged with and strengthened relationships with local Universities (Cardiff University: Live local, learn Local). The University was also able to promote opportunities and availability of courses and support.

Brief statement of the charity's policy on reserves

Women Seeking Sanctuary Advocacy Group Wales closely manages its finances. The Board has a delegated Finance Officer who presents quarterly financial reports to the Board of Trustees at every meeting.

We are currently in a good situation to continue our work into the next year.

The Board of Trustees acknowledges that unrestricted funds which have

not been designated for a specific use should be maintained at a level equivalent to between three months expenditure.
