Helston downsland charity

This year was significant for the charity. It marked our bi centenary and emphasised the significance of the charity to our local community of Helston. During the year we saw the delivery of our promised grant to the South Kerrier Alliance facilitating the transfer of Coronation park from local authority control. The charity had agreed grant payments for the years 2016 to 2019 inclusive. However the delay in devolution meant SKA did not obtain the transfer until 2018. Having paid the delayed annual payments for 2016/17 together with the 2018 payment, we received a request to pay the 2019 payment a month early, within this accounting period. The trustees agreed to do this, effectively completing 4 years payments within a year.

The benefit of our support to SKA are visible to the entire community. The pledge from this charity was sufficient to enable SKA to obtain funding from other bodies. This has enabled a major refurbishment of the lake and skate park which remains a much loved and well used community asset. This would not have been achieved without the commitment of this charity During this year the charity also agreed a long term lease for the field at Gays Hill with our tenant. Due to difficulties with negotiations the charity received the payments for the previous and this year within the accounting period. The new agreement is for five years and is subject to annual RPI indexation. This benefits not only this charity but also the Helston Welfare Trust who receive 31% of the income

The accounts show a £25000 transfer from our investment fund into our current account. This sum represents the income from March 2017 until May of this period, whilst the charity changed banks. The income was held on deposit within our portfolio through this peiod.

The charity investment portfolio continues to provide a steady return whilst facing the challenging circumstances of a potential trade war and Brexit issues. The portfolio is constantly monitored to provide a balance between income and capital growth. The chair and vice chair held a meeting with our investment manager to review performance. The charity continues to be a relevant small local charity supporting the local community. I hope that the charity will continue to be so in a further 200 years.

Re: Refurbishment of the Skate Park, Coronation Park, Helston

Thank you for the fantastic support that the Helston Downsland Charity have given to the Coronation Park project. The commitment of the Charity at the very start of the project was fundamental and it was only after your support was confirmed that we were able to convince Cornwall Council, West Cornwall Local Action Group and Cornwall SITA Trust to provide the necessary match funding to make the project a reality.

As you are aware, several of the funders will only remit monies for a project once the activity they are funding is complete and paid for. This has been a constant challenge to our cash flow through the project and so your support in remitting a large part of your funds at an early stage was again, essential and much appreciated.

We are now in a position where we have almost completed the full project. The Skate Park is the last phase and you will have seen that the old equipment has been removed, the whole area resurfaced and the badly draining section now resolved and the seating refitted. The Skate Park equipment was ordered in December and we are expecting delivery towards the end of February.

With large parts of the project complete the invoices continue to roll in and we are extremely tight on project cash flow. We are awaiting WCLAG claims to remit plus SITA (who are part funding the skate equipment to the value of £30,000) will only provide funds once the equipment is installed, paid for and signed off by a third-party valuer. David Perry for Wm Weller & Co (Quantity Surveyors) has been providing the necessary third-party valuations throughout the project and so he will provide this sign off for the Skate Park once complete in order to release SITA funds. You are welcome to copies of this valuation.

Cash flow is therefore very tight for SKA at the moment and it would help us tremendously if you are able to remit to us as soon as possible the remainder of the Helston Downsland Charity funding.

As noted above you are very welcome to copies of the Wm Weller valuations and I'm happy to go through the overall cash flow for the project with you. We will of course provide a full financial project report once the project is complete which will reconcile activities and funding to all of the invoicing.

I hope this will be OK. Please let me know if you need any further details.
