## **Annual Progress Report 2019**

## **SUMMARY**

Malawi Wildlife Trust was registered as a Charitable Incorporated Organisation in 2018.

Its mission is to protect Malawi's wildlife and safeguard its natural habitats, which will be achieved through two approaches;

- 1. Promote for the benefit of the public the conservation, protection and improvement of the physical and natural environment in Malawi.
- 2. Advance the education of the public in the conservation, protection and improvement of the physical and natural environment.

This short report outlines developments towards operations for 2019 which mainly focused on developing the foundational documents, systems and protocols required to operate efficiently. Unfortunately progress in advancing the aims of the charity since completing this work has been slow due to changing personal commitments of the trustees and the volunteer director appointed. As such no active fundraising has occurred and no grants issued hence the brevity of this report.

It is hoped that during 2020 some renewed vigour can be applied to building on the potential that initially stimulated the decision to try and start the charity. Should this prove challenging the trustees will review the viability and usefulness of maintaining MWT as a registered charity towards the end of the year.

# 1. People

Trustee meetings have been held to move forward on operations. In order to achieve this, a volunteer director, Kate Moore, has been appointed.

- Financial manual & financial policy
- Grant making policy

# 3. Building partnerships

*Project partners:* Meetings and discussions have been held with various potential partners to understand their possible requirements and projects that may require funding.

Potential funders: Several funders have also shown an interest in working with MWT to fund projects in 2020.

# 4. Marketing

A website domain has been secured and draft logos produced.

## 5. Finances

A CAF bank account is now in operation and a Paypal account has also been opened to receive online donations. CAF bank required an initial deposit of £1000 to open the account which was provided via a private donation in 2018.

There has been 1 donation this year of £50 received from the Charities Aid Foundation (CAF) which is a grant making foundation linked to the CAF bank with whom MWT holds its bank account.

There have been no outgoing payments other than the account charge of £5.00 per month
