Trustees Annual Report. 1st April 2018 to 31st March 2019

Kirklees Communities Who Can CIO was set up following the closure of Kirklees Federation of Tenants and Residents Associations (KFTRA). More recently KFTRA had been operating under the branding of Communities Who Can with an aim of moving away from its traditional TRA remit to one of a broader and more inclusive community focus.

KFTRA was an umbrella organisation for around 100 community groups throughout Kirklees and delivered a number of successful initiatives including the Communities Who Can Health and Well-being Project. Its membership voted to move away from their existing governance arrangements and become a CIO, but their Board was unable to make progress and funding came to an end. KFTRA governing document stated that any remaining funds should be transferred to an organisation with charitable purpose and the majority of the membership voted that it should be used to establish Kirklees Communities Who Can CIO

The CIO has not made as much progress as the Trustees would have liked in the first 12 months due to a delay in the transfer of funds. There was also uncertainty as to weather the funds would come across and how much funding the CIO would receive. The Trustees ensured a number of basic policies were in place, but agreed to wait until after the funds were received before engaging a consultant to further develop those policies and support the Trustees in developing the business plan.

In this financial year the CIO has received payments of £5,000 and £84,000 but has had no expenditure as meeting rooms have been provided free of charge and Trustees have not claimed expenses.

The immediate focus for the forthcoming year is to work with a consultant to ensure our policies and procedures are in place and that we have a clear focus and direction through our business plan, recruiting new Trustees and launching ourselves in the public arena by offering a number of small grants around each of our Charitable objects.

As the CIO has not incurred any operating costs or undergone any charitable activity this financial year, and as the only financial activity has been the 2 payments into the bank account by KFTRA and the liquidator as shown on the bank statements. We did not understand the benefit of having an external examination of the accounts. So unfortunately have not had our accounts checked by an independent person. We apologize for this and will do this immediately if required.

6. Progress

6.1 Funding: The CIO had received an initial donation of £5,000 from Kirklees Federation of Tenants and Residents Associations (KFTRA) to aid the CIO with set-up costs. There has since been a considerable delay in the transfer of further funds, through the Liquidator, due from the liquidation of KFTRA, to Kirklees Communities Who Can C.I.O.

These funds have now been received, reported by The Treasurer as bringing the total funds held to £94,927.31p.

- 6.2 Trustees: One trustee, Mr S Jordan, had vacated his position of trustee by default, leaving a vacancy for a new Trustee. This position will be filled in the near future.
- 6.3 Consultancy: The CIO was unable to appoint a consultant to work on the development of a range of policies until after the receipt of the bulk of funding. A

range of policies that will enable us to meet our Objects has since been developed through working with a consultant.

The Chair thanked everyone for their attendance and closed the meeting. The date of the next AGM is not set.
