## **Governing Documents**

Taking Flight Theatre Company is governed by Memorandum and Articles of Association incorporated 5<sup>th</sup> September 2008.

## Recruitment, Appointment and Training of Trustees

New trustee callouts are produced in written and video format (BSL/ captioned) and circulated widely, through traditional and non- traditional channels ensuring the widest range of trustees can apply. Trustees apply by letter or video, are met by the Board, interviewed and elected thereafter. The existing Board of Trustees has a wide range of skills and experience in a variety of sectors including the arts, similar charities, industry and professional services and the public sector. These skills are utilised to maximise the benefit to Taking Flight. During the year we have undergone a great deal of work on governance, engaging the board more genuinely with the day to day work of the company.

# **Financial Review**

The company is still working towards holding 10% of total revenue as unrestricted operating reserves. It has been difficult to achieve this goal during the year this report relates to during a dip in funding resulting in the focus on organisational development, rather than artistic output.

At present the company does not hold reserves at this level as it does not receive core revenue funding. Each project is funded a specific grant calculated to cover the costs of the project. At 31st March 2019 the company held total reserves of:

# Public Benefit Statement

The Trustees of Taking Flight have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers or duties.

The inclusion of D/deaf, disabled and sensory impaired people in all Taking Flight's professional projects, the training opportunities offered, both to participants/ beneficiaries and more widely in the arts sector, plus the outreach in mainstream and specialist schools through The Arts Council of Wales Lead Creative Schools Scheme have sought to challenge negative perceptions of disability and improve social cohesion. The public benefit of this is enormous and will have far reaching and long - term effects on encouraging good citizenship. By showcasing the value of difference and celebrating the abilities of all, Taking Flight remains true to one of its core aims of challenging and changing perceptions of disability and impairment in the wider public.

The company continues to offer consultation for university theatre courses and mainstream venues and producing companies on integrating access and considering and welcoming D/ deaf and disabled audiences. The relationship with Bath Spa University has strengthened throughout the year, with TF consulting on access on student productions as well as taking on placement students from the performing arts dept. On peeling this was a disabled young woman who aims to be a stage manger. The aim of the consultation strand of the work is to support external organisations in understanding how they can best support disabled audience *and creatives* with the overall goal of increasing employment opportunities for disabled creatives outside of Taking Flight, and ensuring disabled & D/deaf people are better represented both on and off stage and in the audience.

- To influence other arts & non arts organisations, individuals, venues & organisations to value D/deaf & disabled audiences, customers, collaborators

# Business and Organisational Development

During Summer 2018 the company underwent a period of deep organisational development with Arts Consultant, Lawrence Becko. As part of the Creative Steps programme supported by Arts Council Wales, Lawrence spent a significant amount of time with Taking Flight Staff, Board and Stakeholders, exploring core values, organisational development and how to move forward creating a sustainable organisation.

His report recommended clearer messaging of core activity and values, redevelopment of company mission, vision and objectives, greater need for artistic focus (including streamlining work undertaken in line with core values). His full report is attached here. Organisational Development is ongoing and we continue to work alongside Lawrence Becko to further the organisation's sustainability.

# <u>Artistic work</u>

Taking Flight has used the 2018/19 year to take exciting artistic leaps, and develop their style, and approaches to theatre-making.

# <u>peeling</u>

The main artistic project of the year was peeling by Kaite O'Reilly. This was a female-created project with over 30 women working on the show in various capacities. As well as the core creatives there were a team of 12 mentees who were paired with creatives working on peeling and with Taking Flight, including 4 deaf/disabled women. All the women were attached to female mentors for the duration of the project. We were also able to work with Hannah Treadway a disabled assistant director, on the project.

Continuing the commitment to impact beyond the stage, peeling opened on International Women's Day at Riverfront, Newport (sold out) with programme of celebratory activity around women and women's art; including free "Creative Spark" workshop with Kaite O'Reilly for people identifying as female - who then performed the poems they wrote in the foyer before the opening show. There was also a presence beyond the performance via city centre engagement in central Newport and the 'what does it mean to be a woman?' washing line.

The production was critically successful, garnering a 5 Star review from The Stage and a 4 Star review from The Guardian. After its initial run in Newport the production toured Wales.

Following this the production was invited to Germany to TheaterFestival Grenzenlos Kulture in Mainz where we have been asked to perform on the weekend that celebrates and showcases best practice in access from Europe! This is both a brilliant opportunity to share the work undertaken on this project, but also to showcase Taking Flight's artistic work, and work on accessibility to leading theatre makers in Europe.

### You've Got Dragons

This family show undertook a huge England tour which included Jackson's Lane. Poole Lighthouse and Harrogate Theatre. There was a total of 3248 audience members and 767 family workshop participants over the run. This was funded via £20,000 from Foyle Foundation and the rest from Arts Council England. You've Got Dragons was selected by House consortium to tour again in Autumn 2019 following the earlier tour.

In addition to this, Dragons was invited to perform at Birr in Ireland as part of Hullaballoo Children's Theatre Festival. We worked with an Irish Sign Language translator and a Deaf ISL user to translate BSL into ISL in advance of a well- attended performance and multiple craft and practical workshops with children and their families at Birr Theatre.

### I Said I Love You (Steph Back)

In June and July, a long time collaborator with TF, Deaf actor Steph Back was successful in gaining funding from Arts Council Wales for new Research and Development project. She asked Taking Flight to support her in this process, as a co-production with Neontopia (another Cardiff based company) Neontopia specialise in bilingual theatre and they assisted on this trilingual piece exploring communication and language (performed in English, BSL and Welsh). Elise Davison (TF director) supported the exploration process in the rehearsal room, and Creative Producer Beth House provided producing advice and support,

### Mess up the Mess- Winter Wonderworld

Elise was guest director on this bilingual Christmas 2018 show by Mess Up The Mess theatre Company at National Botanical Gardens. The production used embedded BSL and raised awareness of access to this youth theatre company and to audiences. Alongside Elise's work Beth provided audio description for the production.

### Training and Other activity

Taking Flight secured Arts Council Wales funding to train 12 Wales based creatives in BSL Level 1 via an intensive 2 week course. In addition, they trained 7 Wales based creatives to be Audio Describers which were trialled on illumine's 2023 at Chapter Arts Centre.

### Deaf awareness training

Taking Flight continued to lead on Deaf Awareness training to arts venues in Wales. To compliment the Deaf Awareness training Taking Flight developed blind/ VI training with Tafsila Khan, blind consultant. This training was designed, as with Deaf Awareness training, to be tailored specifically to Arts Venues. It was piloted The Torch in Milford Haven. The trail workshop was a success with excellent feedback.

### Audience Development

We were successful in gaining a large grant from Arts Council Wales to explore audience development across Wales. Working in collaboration with three partner venues, we plan to explore Welsh theatre audiences and accessibility. This Wales-wide audience development programme "The Usual Suspects?"-was created in partnership with Riverfront Newport, Theatr Clwyd in Mold and Torch Theatre Milford Haven. This project is ongoing and will see us creating teams of buddies to support isolated or marginalised people to attend theatre events.

This report was developed by Dr Emily Garside (Chair of the Board of Trustees), Beth House (Creative Producer) and was overseen by the board of trustees.
