

## 7th Grantham (St. John's)

## Summary of accounts 31st March 2019

Accounts for the financial year ended 31<sup>st</sup> March 2019 have been produced using the information from the bank statements, along with receipts and information regarding events/activities supplied by the leaders via the Group Scout Leader.

Where payments have been made via the account or by cheque for an event or activity, this expenditure is included in the total expenditure for that event or activity. A separate income/expenditure sheet has been included in the account with the appropriate information shown.

The income for this year is a lot higher than normal and this is due to the Cubs running two large scale events within a year, one being Lincub (a county organised event) at which a number of groups from Grantham District went as one group, the cub leader from 7ths being the organiser of the Grantham Contingent, which resulted in all monies going through our account. The other activity was CUBJAM, which although being held in May 2019 (the next financial year) meant that most of the monies were collected in during the 2018/2019 financial year.

As you can see from the figures, the majority of the monies for these events were also paid out during the 2018/2019 financial year.

There were two other large scale events, one organised by the Beavers and Cubs to White Post Farm and the Cub Ice Hockey/Ice Skating weekend.

Without these four events the total income for the year would have been within the boundaries of average for previous years.
