Over FY 18/19 we have had an influx of visitors, which we relate to the retirement of the Panavia Tornado from RAF service. This aircraft has served the RAF with distinction at RAF Marham for since 1983. The ACH have a great number of Tornado items and artefacts on display, allowing the general public to see what it was like to operate them.

Para 1.20	In April of 2018, the AHC negotiated the loan of the cockpit section oh Handley Page Victor XH164, which is currently undergoing restoration. Once completed, this exhibit will hopefully be accessible to the general public by prior appointment. To coincide with the retirement of the Tornado from RAF service, renowned aviation author, and AHC staff member Ken Delve, updated his book 'The operational history of RAF Marham' to encompass the last 25 years of the stations history. The AHC had this published, and was already taking pre-orders for copies in March 2019. All profits from the sale of the boob will go into funding the upkeep and improvement of the AHC. The AHC linked up with a local scout group, and created an 'Air Researcher' badge. This saw the scouts coming into the centre to learn about air power, and then utilise the various display and books to research projects of their own. The digital archive was expanded and now contains over 2,500 items or collections. A new display was created to prepare for the arrival to RAF Marham of 617 Sqn, with a nod to some of their more notable past, including the 75th anniversary of the dams raids.
