

Trustees' Annual Report

1. Introduction

- 1.1. Making Sense became a Charitable Incorporated Organisation (CIO) on 1 August 2023 converting from a community interest company known as Making Sense CIC.
- 1.2. This is the first Trustees' Annual Report and covers the initial eight months of operation as a CIO from 1 August 2023 to 31 March 2024.
- 1.3. Future annual reports will cover the twelve months April to March each year.

2. Structure and Governance

- 2.1. Making Sense CIO is governed by a written constitution which sets out our aims and duties including the role and duties of the Trustees (of which there must always be at least three) to manage the affairs of Making Sense CIO.
- 2.2. The trustees meet quarterly, or more often as needed, and receive regular updates on the CIO's progress and financial position.
- 2.3. The table below shows the trustees in place during the period of this report and when they were appointed. A summary of the trustees' experience is attached as an appendix to this report.

3. Our aims

- 3.1. To promote social inclusion for the public benefit by preventing people from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society, by providing creative workshops, training and materials for care staff to enable them to lead sensory art sessions, and support to improve access to the creative arts.

“Socially excluded’ means being excluded from society, or parts of society, because of one of more of the following factors: youth, old age, physical or mental disability.

4. Our achievements

- 4.1. Our aims have been achieved through the delivery of a range of workshops and creative materials: -

- **Dwylo Bach (Little Hands)**

- Workshops for babies and toddlers and their care givers

- **Reminiscence Collections**

- A partnership with the Denbighshire Library Service, to use and promote reminiscence collections through a programme of memory cafes for people living in the community and training sessions for care staff and people working in Dementia Services across the county.

- **Sensory Parcel Service**

- Resources and workshops for people with profound and multiple learning disabilities and the staff that support them

- **Care Creatively**

- Artist led workshops, training and resources to support the wellbeing of people living with dementia and staff and carers that support them

- 4.2. More detail on each activity is given below. We are reliant on, and very grateful for, grant funding to support our activities.

Dwylo Bach: Funding £14,780 – 707 community benefit

- Dwylo Bach (Little Hands) are our bilingual workshop sessions led by artists and inspired by the work of artists, makers and exhibitions from galleries across North Wales. The workshop sessions provide an opportunity for babies and toddlers to explore a wide range of objects and materials, sounds, tastes and smells freely with few restrictions - enabling them to learn through play and creativity.
- For parents and carers, the sessions offer a new way of thinking about play and learning which has led many to rethink what play opportunities to offer their children in future.
- Our sessions are entirely child led and allow space for parents and carers to connect with each other and form friendships.
- In 2023 a grant from Clocaenog Forest Wind Farm Fund and match funding from Arts & Business Cymru, enabled us to run an initial project in the rural areas around Llanrwst. We offered a series of workshop sessions which were all fully booked and left our families asking for more!
- This partnership funding meant we could run further sessions in Denbighshire's rural areas and made it possible to bring the arts to the heart of rural communities, working with a young audience that often misses out on engagement with the arts.
- The babies, toddlers and their grown-ups benefited enormously from the cultural and creative stimulation and an opportunity to meet with other care givers in a relaxed informal environment.
- Our sessions were extremely popular and always fully booked and there is an appetite for more early years creativity in the areas served by RWE and Clocaenog Forest Wind Farms.
- Our findings identify the importance of introducing creativity into early years learning as it supports the growth and development of all children. The freedom to manipulate different materials in an organic and unstructured way allows for exploration and experimentation, it is not only fun but educational as well.

Reminiscence Collections –Funding £5,000 – 85 community benefit

- A grant of £5,000 from Denbighshire Voluntary Services funded a second phase of a project using five reminiscence object collections created through a consultation process with care home residents, staff, families and volunteers.
- This project was a partnership with the Library Service, to use and promote the reminiscence collections through a programme of memory cafes for people living in the community and training sessions for care staff and people working in Dementia Services across the county, reaching people via the libraries in each town.
- As a community, the members now see the value of memories and looking back, to include members of the community living with dementia.
- The collections are now available for anyone to loan via Denbighshire Library Service who host the collections. Denbighshire Libraries are happy to continue loaning out the collections and are keen to continue working with us and want us to make more collections as 5 is not enough!!
- There is a wider awareness of the collections for dementia support workers and volunteers - there is a need to continue providing reminiscence cafes in the libraries.
- Dementia professionals are aware that the resources exist and will let individuals and care homes know how useful they are as a resource.

Sensory Parcel Service - Funding £17,000: 200 Community Benefit

- This project has been growing and developing since 2020 and is an ongoing service.
- We provide creative and sensory resources for North Wales Day centres for adults with profound and multiple learning disabilities (PMLB). The monthly resources are aimed to support staff, giving them the skills, resources, confidence and enthusiasm to run their own sensory and creative sessions with the people they support.
- We want to support these staff to provide stimulating, sensory activities to engage with people with sensory needs who are often under stimulated and feel isolated and lonely.
- We have received regular funding from the North Wales Learning Disability Transformation Fund and from Denbighshire Voluntary council for this project.
- Each sensory parcel is developed by Making Sense in collaboration with an artist or exhibition. We work with a local day centre to try out the parcels and packing them, before sending them out to eight-day centres from across north Wales.
- Staff and carers will feel valued and supported with the sensory parcels providing a regular source of new ideas for creative and immersive sensory activity with have the skills, resources and confidence to take part in and deliver creative sensory sessions. People with PMLD will feel more stimulated and engaged through taking part in more meaningful sensory activities and visits, their sense of wellbeing will improve.

• Care Creatively - Funding of £46,000

- Care Creatively is our work with care homes in Conwy, supporting activity coordinators through artist residencies and training
- This project only commenced in January 2024 and continues until October 2024.

- 4.3. In addition to core funding to support our creative workshops and activities described above, we have been successful in securing funding to improve the sustainability of the newly formed CIO.
- 4.4. Shared Prosperity Fund grant of £46,000 has allowed us to employ a part time administrator which has been extremely important in the formation of the CIO, putting financial systems in place that have set the CIO for the future. This grant enabled our CEO to lead on development of the charity and enabled us to move it forward. During 2024-25 the grant will fund a new website and leave us with a sustainability plan and a fundraising strategy going forwards.

5. Financial Summary

- 5.1. Our Statement of Financial Affairs and Balance Sheet for the period are also submitted along with this annual return.
- 5.2. In the eight months to March 2024, we had income of £142,561 and expenditure of £57,805, carrying forward balances of £84,755 and the position is summarised in the SOFA sheet, included with this report.
- 5.3. We account for grants in full in the financial year when the grant is received. At year end, we held restricted fund balances of £96,900 reflecting grants received but not yet expended.
- 5.4. We held unrestricted fund reserves of £15,969 These are held to meet continuing operating expenses (including office tenancy) and to contribute to the continued sustainability development of Making Sense
The balances carried forward are
Restricted Funds £68,787 and unrestricted £15,969 – making up the total balances of £84,755 as shown in the SOFA
- 5.5. The principal financial risk facing our charity is our ability to successfully apply for grant funding to enable us to deliver workshops and activities to meet our aims.
- 5.6. We do not hold funds as custodian trustees on behalf of others.
- 5.7. There are no uncertain liabilities affecting our financial position or continued operations.

Introducing our Trustees

Anthony Farnsworth	Chair of Trustees Worked for Devon County Council as a Social Worker before joining the NHS in 1995. After working in Exeter for several years he moved to Torbay Care Trust in 2006 and became Chief Executive in 2009. After retiring from the NHS in 2015 Anthony has worked for himself in various senior roles in both NHS and Social care organisations.
Alan Griffiths	A parent/carer of a man with a Learning Disability, Autism and Epilepsy Alan has been an advocate for people with a LD for a long time. Alan was a trustee for National MENCAP as well as Chair of both Liverpool and St Helens Mencaps. He is a retired Chartered Civil Engineer and was responsible for the expenditure of millions of pounds worth of Capital Works, including Urban Regeneration during the Objective One years (and beyond) in Merseyside.
John Rostron	CEO of the Association of Independent Festivals. Former CEO of the Welsh Music Foundation and co-founder of the Welsh Music Prize. He has also held consultant and advisory roles at Arts Council Wales and Sound Diplomacy, as well as having been a Development Manager at From the Fields.
Maggie Sheppard	Retired former local government senior manager and public sector accountant with good understanding of public finance, governance and reporting. Prior to retirement at the end of 2021 Maggie was head of pensions for a local government pension scheme and has led teams managing council procurement, contract management and social care finance in Cheshire.
